## The General Jim and Pat Boswell Scholarship Program Privacy Statement

### NOTICE TO APPLICANTS:

Since the 7th Infantry Regiment Association (the "Association") is a private, non-profit corporation, the Privacy Act of 1974 (5 V.S.C. 552c) is not applicable. However, the Association wants participants to be fully aware and to acknowledge the need for and the required use of information provided.

"We understand that failure to provide all requested information to the best of our ability may impact the selection process. We, the applicant and parent(s)/sponsors, voluntarily provide required confidential information with this application based on the recognized necessity of the data to allow for the proper evaluation of the eligibility for Association financial assistance. To this end, we fully understand that:

- Participation in the General Jim and Pat Boswell Merit Scholarship Program is voluntary.
- The requested information is needed for that participation.
- The principal purposes of the requested information are to:
  1. Verify the identity of the applicant.
  2. Determine applicant's eligibility for program benefits.
  3. Permit administrative processing and evaluation for scholarships.
  4. Allow required servicing and administrative management of approved scholarships.
  5. Publicize scholarship recipients in various publications.

We understand fully the foregoing and hereby authorize the Association to disclose information relating to this application for scholarship whenever the disclosure is necessary for the processing, servicing, granting or publicizing. This includes submitting grades or GPA's electronically to Board of Directors at their request. We further understand that, as a result of this consent, the Association will not keep an accounting of disclosures of information regarding this application for scholarship since this notice informs us of the uses which may be made of the information.

### We understand further that:

- Students receiving scholarship funds must be considered by the accredited institution as a full time student for the entire academic year in pursuit of an Associate's or Bachelor's degree.
- Students must maintain a cumulative GPA of not less than 2.5 on a 4.0 scale.
- Requested financial assistance is needed to allow educational pursuits and that all funds received will be used only for educational expenses.
- For continued educational assistance, a new application must be submitted to the 7th Infantry Regiment Association for consideration for each academic year.
- The student's sponsor must remain a member of the Association in good standing during the entire period the student is receiving financial assistance from the Association.

"We have read carefully the completed application and it is accurate and complete to the best of our knowledge. We authorize the 7th Infantry Regiment Association or its representative, as may be required, to verify any information herein by contacting an appropriate office or official.
